1. INTRODUCTION

- 1.1. At Olive Clothing Limited we are committed to safeguarding and preserving the privacy of our visitors. This Privacy Policy document explains what happens to any personal data that you provide to us, or that we collect from you whilst you visit our site and how we use cookies on this website.
- 1.2. We do update this Policy from time to time so please do review this Policy regularly.

2. INFORMATION THAT WE COLLECT

- 2.1. In running and maintaining our website we may collect and process the following data about you:
- 2.1.1. Information about your use of our site including details of your visits such as pages viewed and the resources that you access. Such information includes traffic data, location data and other communication data.
- 2.1.2. Information provided voluntarily by you. For example, when you register for information or make a purchase.
- 2.1.3. Information that you provide when you communicate with us by any means.

3. USE OF COOKIES

- 3.1. Cookies provide information regarding the computer used by a visitor. We may use cookies where appropriate to gather information about your computer in order to assist us in improving our website.
- 3.2. We may gather information about your general Internet use by using the cookie. Where used, these cookies are downloaded to your computer and stored on the computer's hard drive. Such information will not identify you personally; it is statistical data that does not identify any personal details whatsoever.
- 3.3. Our advertisers may also use cookies, over which we have no control. Such cookies (if used) would be downloaded once you click on advertisements on our website.
- 3.4. You can adjust the settings on your computer to decline any cookies if you wish. This can be done within the "settings" section of your computer. For more information please read the advice at AboutCookies.org.

4. THIS WEBSITE USES GOOGLE ADWORDS

4.1. This website uses the Google AdWords remarketing service to advertise on third party websites (including Google) to previous visitors to our site. It could mean that we advertise to previous

visitors who haven't completed a task on our site, for example using the contact form to make an enquiry. This could be in the form of an advertisement on the Google search results page, or a site in the Google Display Network. Third-party vendors, including Google, use cookies to serve ads based on someone's past visits to this website. - 5.1.4. If you have previously purchased goods or services from us we may provide to you details of similar goods or services, or other goods and services, that you may be interested in.
- 5.2. We never give your details to third parties to use your data to enable them to provide you with information regarding unrelated goods or services.

6. STORING YOUR PERSONAL DATA

- 6.1. In operating our website it may become necessary to transfer data that we collect from you to locations outside of the European Union for processing and storing. By providing your personal data to us, you agree to this transfer, storing and processing. We do our utmost to ensure that all reasonable steps are taken to make sure that your data is stored securely.
- 6.2. Unfortunately the sending of information via the Internet is not totally secure and on occasion such information can be intercepted. We cannot guarantee the security of data that you choose to send us electronically, sending such information is entirely at your own risk.
